Whereas the Air Act came into force in the whole of the State of Rajasthan with effect from 16.6.1981. 3. And whereas the Air Act has been enacted to provide for the prevention, control and abatement of air pollution. 4. And whereas section 21 of the Air Act prohibits establishing or operating an industrial plant and discharge of air pollutants without obtaining prior consent of the State Board. 0 5. And whereas, Hon'ble National Green Tribunal, Principal Bench, New Delhi (NGT) delivered a decision on May 08,2013 in the application no. 37 of 2012; Wassan Singh V/s 17 state of Punjab and others, and it was enjoined upon all the industrial operation and process to down their production activity which are operating without proper consent of the State ard. and whereas the Industry was inspected by team of Board officials from RO, Alwar on dated 6 14/11/2018 for verification of air pollution control measures.  $\overline{v}_3$  And whereas a SCN for intended refusal of consent applications & intended directions for closure was issued by RO, Alwar vide letter dated 20/11/2018. And whereas industry has failed to submit any reply of SCN dated 20/11/2018 in RO, Alwar 8. & the consent applications has been refused by RO, Alwar vide letter dated 06/12/2018 & 10/12/2018. 9 And whereas the industry is operational without obtaining Consent to operate from the State Board & without installing pollution control measures. 10 And whereas the industry has not installed requisite air pollution control measures to achieve emission standards of SO<sub>2</sub> & NO<sub>x</sub> as prescribed under Environment protection Act, 1986. 1 - ... a whereas above stated non- compliance of the provisions of the Air Act have been viewed jously by the Board. 12. And whereas keeping this in view the Board has been conferred power to take such steps as are deemed necessary for the prevention, control and abatement of air pollution. 13. And whereas the State Board in order to prevent and control air pollution being caused by the industry and stop non-compliance of the provision of the Air Act, is competent to issue any directions under section 31A of the Air Act in writing to any person, officer or authority and such person, officer or authority shall be bound to comply with such directions.

section 31A of the Air Act, issues following directions:-

- a) You are directed to close down your industrial plant forthwith.
- b) District Collector, Alwar to ensure closure of the industry.
- c) SE (O & M), Jaipur Vidhyut Vitaran Nigam Limited, Alwar shall disconnect the electricity supply to the industry.
- d) Regional Officer, Regional Office, Rajasthan State Pollution Control Board, Afwar is directed to seal the Diesel Generator Sets, if any and such other equipments so as complete closure of the industrial plant and report that the direction as above have complied.

Please note that the non-compliance of the above directions is punishable under section 7(1) of the Air Act with imprisonment for a term which shall not be less than one year and six months but which may extend to six years and with fine.
