OFFICE ORDER

The Hon'ble National Green Tribunal vide order dated 06.03.2019, in the matter of Original Application No. 34/2014(THC) Digvijay Singh V/s State Of Rajasthan & Others, directed that no further new industries particularly which generates trade effluent should be allowed by Rajasthan State Pollution Control Board till existing industry meet the prescribed effluent standards in the Balotra, Bithuja and Jasol.

In compliance of Hon'ble National Green Tribunal order dated 06.03.2019, the State Board has issued office order on 02.04.2019 and directed that no Consent to Establish will be issued to any new industry or CTE for expansion of any existing industrial unit which generates trade effluent.

Several such applications for consent to establish are pending with the State Board.

Therefore, the matter has been re-examined by the State Board in light of NGT order dated 06.03.2019 and it has been decided that the Consent to Establish may be considered in accordance with State Board guidelines for establishment of captive ETP & recycling plant issued vide order dated 08.06.2017 to the stand alone industrial units (new industry or expansion of any existing industrial unit), having ZLD based own ETP's and adequate scientific arrangements for maintaining Zero liquid discharge.

This bears approval of the competent authority.
