## Office Order

Subject – Modifications in the working of Groups in the Head Office for grant/ refusal of consent to establish/ consent to operate under the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 and authorization under Hazardous and Other Waste (Management & Transboundary Movement) Rules, 2016.

In order to expedite disposal of applications and address the drawbacks of the present system under which consent and authorization files of industries/ activities/ processes/ mines etc. are processed by different Groups, the working of the Groups in the Head Office for grant/ refusal of consent to establish/ consent to operate under the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 and authorization under Hazardous and Other Waste (Management & Transboundary Movement) Rules, 2016 is directed to be modified as under:-

- 1. The applications for CTE/ CTO under Water Act 1974 and Air Act 1981 and authorization under Hazardous and Other Waste (Management and Transboundary Movement) Rules, 2016 of one particular industry/ projects/ activity shall be processed by the same Group.
- 2. All the authorisation files from the Group (HSW) will be transferred to the respective Group dealing with the consent files.
- 3. The files of Common Disposal facilities, Pre-processing facilities, One time authorization, Third party transporters, Tyre Pyrolysis Plants etc. being dealt by the Group (HSW) and which are not assigned to any other Group shall continue to be with the Group (HSW).
- 4. The Group (HSW) will monitor the overall implementation of the HOWM Rules 2016, prepare annual inventory of the wastes and move/ initiate policy decisions related to the Rules.

The order shall come into force with immediate effect.
