Sub: Seeking of NOC from Central Ground Water Authority (CGWA) for abstraction of ground water for processing of consent applications - Regarding.

Ref.: Minutes of Inter-departmental Meeting held under the chairmanship of the Chief Secretary, Govt. of Rajasthan on 24.06.2020 issued vide letter no. F.12(PSC-36) RPCB /Jaipur/491-510 & 677-96 dated 30.06.2020 & 09.07.2020 respectively.

In compliance to the minutes of inter-departmental meeting held under the chairmanship of the Chief Secretary, Govt. of Rajasthan dated 24.06.2020, to discuss issues related to processing of consent applications under the Water Act, 1974 and the Air Act, 1981, following decisions were taken regarding NOC from Central Ground Water Authority (CGWA) for abstraction of ground water for processing of consent applications:

(i). In compliance to Hon'ble National Green Tribunal order, industries are required to obtain NOC from Central Ground Water Authority for abstraction of ground water. In such case, the applications for Consent to Establish/ Operate received in the State Board shall be decided on the basis of application submitted by the project proponent in Central Ground Water Authority for abstraction of ground water.

Henceforth, new applications for Consent to Establish/ Operate shall be initially examined at the Pre-Screening cell and shall be returned back to the project proponent in case of non-submission of application submitted by the project proponent to Central Ground Water Authority for obtaining NOC for abstraction of ground water.

This order shall come into immediate effect. All the concerned Group Incharges, Regional Officers may take action accordingly.
