## Office Order

In order to ensure that Consent to Establish and Consent to Operate applications are decided in mandatory time limit of 120 days, all officers are directed to henceforth not to keep applications pending where proponents have failed to submit necessary documents despite issuance of deficiency letters. The Group Incharge and Regional Officer are directed to dispose all pending Consent to Establish and Consent to Operate applications and update on MIS within 15 days of issue of this order.

It is further directed that all long pending CTE & CTO are to be disposed off in the next 3 weeks. Pre-requirement of inspection will be still mandatory for cases where earlier Consent to Operate/ Authorization was refused / revoked or directions under section 33 (A) of Water Act, 1974, section 31(A) of Air Act or section 5 of the Environment (Protection) Act, 1986 has been confirmed. All issuance would be subject to post audit of Pollution Control Measures (PCM) and Consent conditions. In case, it is found during post-inpection, the industries have flouted conditions of the consent / authorization / or inadequate PCM, the consent will be revoked and directions for closure will be issued under 33 (A) of Water Act, 1974, section 31(A) of Air Act or section 5 of the Environment (Protection) Act, 1986 without any further notice.

Daily report of disposal is to be updated on MIS, Sh. Sanjay Jain, ACP will prepare a consolidated report of all disposals of Regional office as well as Head office, and submit the same for perusal of the Chairperson at 6:00 PM daily.
