Office Order

The Water (Prevention and Control of Pollution) Act, 1974, Air (Prevention and Control of Pollution) Act, 1981 and Hazardous and Other Waste (Management and Transboundary Movement) Rules, 2016 provide that a consent/ authorisation application has to be disposed/ decided within a period of four months. After reviewing the pendency of consent and authorisation applications in the Head Office and Regional Offices, it is directed that in case of applications received from 13.02.2023 onwards, the disposal of consent/ authorisation applications will be ensured within following time lines:-
