Office Order

Detailed procedure for registration of battery dealers under Rule 7 of the Battery (Management and Handling) Rules 2001 was prescribed vide the Office Order no. No. F16 (Gen-110) RPCB/Battery/ Haz./ 1426-1463 dated 23.01.2020. As per aforesaid office order dated 23.01.2020 a fee of Rs. 10000.00 is to be paid by dealers with online application for registration.

After starting the process for registration of battery dealers, the response from the dealers is very poor as less than 50 battery dealers have applied for online registration so far. There is need to bring more and more battery dealers within the frame work of registration.

In order to attract more dealers within the regulatory framework of registration quickly, it has been considered appropriate to offer some incentive to dealers for a limited period.

Therefore, in supersession to previous office order, it is hereby directed that the registration fee of Rs. 10000 (In words Rupees ten thousand only) is waived of for dealers who apply for registration under Rule 7 of the Battery Rules, 2001 upto 31.03.2021. Thus all applications for registration of battery dealers under Rule 7 of the Battery Rules shall be submitted online without making payment of any fee upto 31.03.2021.

This office order shall come into force with immediate effect.
