EXTENSION OF TIMELINE FOR SUBMISSION OF COMPLIANCE REPORTS TILL 30.06.2020 - REGARDING

The State Board by virtue of its powers under the various environmental laws had issued directions to industries/projects/ activities in the state for various compliances with timelines for submission of the compliance reports.

It has been brought to the notice of the State Board that consequent upon the outbreak of COVID-19 pandemic and imposition of lockdown across the country, industries are facing difficulties in ensuring compliances and also submission of such compliance reports which include replies to the show cause notices, compliances of OBH directions, consent conditions, and other regulatory compliances issued by the State Board.

The matter has been examined and in view of the extraordinary circumstances it is hereby decided to extend the timeline for submission of all compliance reports including replies to the show cause notices, compliances of OBH directions, consent conditions, and other regulatory compliances which have been issued by the State Board Head Quarter/ all Regional Offices. All industries who had earlier been directed to submit the compliances during the period of lockdown and the period soon after are now required to submit them by 30.06.2020 irrespective of the timelines given earlier.

It is further clarified that the timelines for submission of compliance reports which are to be submitted after 30.06.2020 shall remain unchanged.

This bears approval of the competent authority.
