## Office Order

All the Health Care Facilities (HCFs) were exempted from depositing gap period fee for operating in past without authorization under Bio-medical Waste Management Rules and consent to operate under the Water (Prevention and Control of Pollution) Act, 1974 and/ or Air (Prevention and Control of Pollution) Act, 1981 vide office order no. F-16(Gen-43) RPCB/BMW/463-502 dated 01.11.2019 provided the applications for the authorization/ consent received up to 31.03.2020. Timeline for submission of applications was subsequently extended from time to time. The exemption was last extended for the authorization/consent applications received on or before 30.09.2022 vide office order no. F-16(Gen-43) RPCB/BMW/1466-1519 dated 30.03.2022. Thereafter, it was not extended.

The Medical & Health Department has requested to waive off the gap period fee for the HCFs which have not taken authorization/consent from the State Board and are in process to apply for the same.

The matter has been re-examined and in order to facilitate the government and private HCFs to apply for authorization/consent and get covered under authorization/consent mechanism of the Board it has been decided that a onetime waiver opportunity be given to all the HCFs and allow them to apply without depositing gap period fee for operation in past without authorization/consent.

In view of the above, it has been decided that exemption from depositing gap period fee in respect of HCFs is extended who apply for authorization/consent on or before 31.10.2023.

This bears approval of the competent authority.
