State Board has issued office order dated 18.02.2021to allow those industries which are desired of setting own ETP with direction that "The unit shall install ETP of adequate capacity having Primary, Secondary & Tertiary units. The treated waste water shall be further passed through minimum two stage R.O. and permeate re-used back into process. The R.O. reject shall be disposed of through Multi Effect Evaporator (MEE) and no waste water shall be discharged inside or outside the premises".

State Board has received various representations regarding relaxation to small scale industries from MEE/ATFD installation. The matter was reviewed and it is decided:-

- 1. Existing units will be allowed with Solar Evaporation Pond and units shall have adequate size of Solar Evaporation Pond:
 - a) Units having two stage R.O. shall have a Solar Evaporation Pond of 50 Sq. Meter per KLD of permissible trade effluent.
 - b) Units having three stage R.O. shall have a Solar Evaporation Pond of 30 Sq. Meter per KLD of permissible trade effluent.
 - c) That the Solar Evaporation Pond shall not be covered from any side and is exposed to direct sunlight through the day.
 - d) Minimum width of Solar Evaporation Pond shall be 5 Meter.
 - e) Effective depth of Solar Evaporation Pond shall be 0.3 meter and total depth shall not be more than 0.5 meter.
- 2. Any expansion application should be considered only after an adequate proposal to upgrade ETP are submitted with MEE for RO reject and ATFD to
- 3. If a unit submits any other proposal for forced evaporation such as Electric Heater then that can also be considered after assessing its adequacy.

All concerned are directed to ensure compliance of the order with immediate effect. This bears approval of the competent authority.
