OFFICE ORDER


It has been observed that in spite of ban on use of pet coke without prior registration with the Board, many industrial units have been found using pet coke illegally. In order to ensure that there is uniformity in action against such defaulting units, it is directed that the following line of action shall be followed in all cases, where pet coke is found in the premises of industries :-

1. In units found using pet coke illegally (pet coke found without permission/ in unregistered industry), the Board should immediately refuse/ revoke the Consent to Operate under Water Act, 1974 and Air Act, 1981 and issue direction for closure under Section 33 (A) of Water Act and 31 (A) of Air Act without seeking any clarification/issuing show cause notice.
2. The stock of pet coke found in the industry premises should be seized by R.O and photograph / videography of the same should also be done. The whole lot of pet coke should be provided to an authorised user, free of cost and the cost of transportation is to be borne by the defaulter unit.
3. If any unit is found using pet coke for the second time, Environment Compensation should be imposed. The period of default for calculating EC shall be from the day of first default by use of pet coke upto the day when the stock of pet coke is disposed as above and consent refusal/revocation and direction for closure is to be issued again immediately.
4. Regional Officers are directed to forward the matter to the Head Office for action within 07 days of conducting inspection after completion of work/action required at the Regional Office level. While sending the report to the Head Office, all evidence/proof/photographs/ video recording etc are to be enclosed.

R.Os should immediately refuse Consent to Operate, if pending at RO Level and forward the matter to the Head Office for further action within 07 days. In case Consent to Operate is valid, RO should forward the case to the Head Office for revocation and for issuing directions for closure.

In case the unit is under the purview of the Head Office, the matter should be referred to the Head Office for further action alongwith evidence (i.e. photographs / video recording sample of pet coke seized etc.) within 03 days.

This bears approval of competent authority.
