Office-Order

In the past, State Board in a few cases, has granted CTE/CTO to multiple units connected to one ETP.

However, it has been noted that following problems are associated with allowing units having multiple connectivity for treatment of waste water and recycling of treated water.

- Units are required to cut the road for laying pipelines.
- In the absence of traceability or identification of underground pipeline, in case, if some unit discharges waste water it is very difficult to identify the violator unit.
- In case of inadvertent breach in pipeline also, it will become very difficult to identify the industry.

To avoid the situation it has been decided, henceforth, not to allow treatment of waste water from multiple units in one unit. All units desirous of having own ETP shall install ETP in their individual units own plots. The Board may allow treatment of waste water into another unit only if the units are situated on adjoining plot and laying of pipeline for carrying waste water for treatment do not involve road cutting and passing through public land.

It is further directed that multiple units presently operative with one ETP shall install individual ETPs within a period of one year from the date of issue of this order.

This bears approval of the competent authority.
