ORDER

The State Board vide Orders dated 03.03.2023, 10.04.2023 and 17.05.2023 had issued directions to industries to set-up new boilers based on clean fuels only subject to specific conditions mentioned therein.

Further, the Ministry of Environment, Forest and Climate Change (MoEF&CC) vide Notification G.S.R. 373 (E) dated 16th May, 2023 has revised emission standards for industrial boilers based on different fuels, which shall come into force on expiry of period of two years from the date of publication i.e. from 15.05.2025.

In view of this, the matter has been reviewed by the State Board and it has been decided that in supersession to the Orders dated 03.03.2023, 10.04.2023 and 17.05.2023, the applicable emission standards in case of boilers based on different fuels will be as prescribed vide the Notification dated 16.05.2023 of MoEF&CC. All the conditions as stipulated in the Notification dated 16.05.2023 shall be strictly adhered to.

However, in case of industries located in the NCR sub-region of Rajasthan, the emission standards specified vide order dated 29.06.2022 shall be applicable.

For the industries located in clusters identified under CEPI mechanism, compliance of State Board directions contained in the order dated 22.03.2023 with respect to permissible fuels and emission standards shall be applicable.

In cases where different standards have been specified under EP Rules 1986, by the Commission for Air Quality Management in NCR sub region and Adjoining Areas and for Critical/ Severally Polluted Areas covered under mechanism specified for Comprehensive Environmental Pollution Index (CEPI), the industry shall have to comply with the standards, which are more stringent.

It is further clarified that State Board orders dated 29.06.2022 and 22.03.2023 shall remain effective.

All Group In-charges and Regional Officers are directed that henceforth all Consent to Establish shall be issued with mandatory incorporation of conditions regarding compliance of the above mentioned standards. Further, Consent to Operate shall be issued with additional specific condition that standards prescribed vide Notification dated 16th May, 2023 of MoEF&CC shall be complied by 15th May, 2025.
