TERMS & CONDITIONS OF TENDER

Note: Tenderers should read these conditions carefully and comply strictly while submitting/sending their tenders:-

- 1. Tender must be submitted in a properly sealed envelop, according to the directions given in the tender notice.
- 2. Tender form shall be filled with ink or typed. Tender filled in pencil shall not be considered. The tenderer shall sign the tender form at each page and at the end in token of acceptance of all the terms and conditions of the tender.
- 3. Rate shall be written both in words and figures. There should not be any error or overwriting. Corrections if any should be made clearly and required to be attested with full signature. The rate should mention with

- the separate element of the Rajasthan State Sales Tax and Central Sales Tax or VAT.
- 4. Price will be including freight, installation with one year onsite guarantee and five year AMC. It may also be noted that in case the machines needs upgrade/change after the trails, the company will do it free of cost.
- 5. The firm shall not assign or sub-let his contract in whole or any substantial part there of to any other agency.
- 6. The EE (Admin) reserves the right to accept any tender not necessarily the lowest, reject any tender without assigning any reasons.
- 7. The tenderer shall furnish the following documents at the time of executions of agreement:
 - i. Attested copy of partnership deed in case of partnership firms.
 - ii. Registation number and year of registration in case of firm is registered with Registrar of Firms.
 - iii. Address of residence and office, telephone numbers in case of sole proprietorship.
 - iv. Registration issued by the Registrar of companies in case of a company.
 - 8. Advance payment will not be made.
- 9. The firm shall deposit 10% of the work order as security money which shall be released after 6 years from the supply of machines including 5 years AMC to the satisfaction of the State Board.
- 10. Firm should have sales tax clearance certificate.
- 11. Firm should have service tax certificate.
- 12.Specifications:
 - i. Bag capacity: 50 Bags (with two separate hoppers)
 - ii. Adjustable hopper size to accomodate various size of Bags.
 - iii. Bags should be folded in Roll form upto max dia. 45mm.
 - iv. Coin acceptor: Support for 5 INR & 10 INR Coin.

v. Support for multiple Bags dispensing at a time (Based on coin inserted).

vi. LED moving massage display for Slogans/Advertisements.

vii. Provision for grouting the machine on floor.

viii. Front access with machanical lock.

13.If any dispute arises out of the contract with regard to the interpretation and/or breach of the terms of the contract the matter shall be referred by the parties to the Head of the Department (Member Secretary, Rajasthan State Pollution Control Board, Jaipur) who will appoint his senior most officer as the sole arbitrator of the dispute who will not be related to this contract and whose decision shall be final.
