CORRIGENDUM

Attention is invited to this Authority's letter of even no. dated 30.04.10 vide which EC for Integrated Township Project of Grass Field Fire Capital Developers Pvt. Ltd. Mehlan, Ajmer Road, Jaipur was issued. The project proponent applied for the corrigendum vide his letter dated 5.5.10. The matter of corrigendum was referred to SEAC, Rajasthan and based upon the recommendations of the SEAC, Rajasthan, the Authority has decided to make following corrections in the above mentioned letter:-

i. Condition No. (xlvi) of the Specific Condition is replaced by the following:

(xlvi) The back up power supply as per the estimate will be arranged through 82 D.G. sets of cumulative capacity 4,857. 50 kVA for power back up in the common areas as stated at page no. 2 of EC letter. The project does not envisage 100% of the power back up through D.G. sets.

ii. The portion "**The SEAC, Rajasthan has observed that significant construction work of the proposed project has been completed and recommended for legal action against the proponent for violation of Environment (Protection) Act, 1986. Hence, legal action may be started against the proponent.**" is deleted from the Endorsement No. 1, 2 & 5.

iii. All other items remain unchanged.
