#### कार्यालय आदेश

राजस्थान लोक उपापन में पारदर्शिता नियम—2013 में निविदाओं पर निर्णय लिये जाने के संबंध में निम्नानुसार समय सीमा का प्रावधान है:—

नियम: 40(2) A decision on acceptance or rejection of bids invited in a procurement process must be taken by the competent sanctioning authority within the period as given below, even if the period of validity may be more, from the date of opening of technical bids where two envelope system is followed, otherwise from the date of opening of financial bids. If the decision is not taken within the given time period by the concerned sanctioning authority, reasons of not taking decision within the given time period shall be specifically recorded by the competent sanctioning authority while taking its decision.

Time schedule for decision on the bids by the competent authority:-

S.No	Authority competent to take decision	Time allowed for decision
1.	Head of Office or Executive Engineer	Twenty days
2. ,	Regional Officer or Superintending Engineer	Thirty Days
3.	Head of the Department or Chief Engineer / Additional Chief Engineer	Forty days
4.	Administrative Department concerned Finance Committee/Board/Empowered Committee/Empowered Board, etc.	Fifty days

Note: (1) The period specified above shall be inclusive of time taken in communication of acceptance of bid.

(2) If procuring entity is other than the departments of the State Government or its attached or subordinate offices, the concerned administrative department shall specify the equivalent authority competent to take decision on the bid."

निगम में तकनीकी बिड खोले जाने की दिनांक से निविदाओं के अन्तिमिकरण की कार्यवाही यथासंभव उपरोक्तानुसार अवधि में ही संपादित की जानी हैं। RMSCL में की जाने वाली निविदाओं में आईटम्स की संख्या, बिडर्स की संख्या, क्लिष्ट तकनीकी विशिष्टताएं आदि कठिनाइयों के कारण उपरोक्त समय सीमा से विलम्ब होना स्वाभाविक है परन्तु उक्त विलम्ब के लिए भी समय सीमा निर्धारित किया जाना आवश्यक है।

# C. Following other issues related to tender process should also be adhere to:-

1. Bidder may be allowed to submit representations regarding specifications and terms & conditions of bid within a period of One day after pre - bid meeting. No representations shall be entertained after that period.

2. Specifications proposed by the demanding organization may cross checked with the specs

approved by the AIIMS/GEM portal/ Other State Medical Corporations.

A clear policy may be framed for clarifications to be sought in bid. Document should clearly speak about which documents clarifications would be sought.

4. No demo in private or non-government medical organizations/hospitals be held.

5. A monthly meeting be held with Director PH, Medical Education Department and RUHS for information/progress sharing about ongoing procurement of equipments so that by the time equipment reaches at the consignee site, other requirements like readiness of site, availability of technical staff can be ensured. Ideally such exercise may be done before float of tender and consignees be finalized only after ensuring feasibility of consignee site.
