

Guidelines for Enlistment of Vendors/ Manufacturers of Vacuum Feed Chlorinators (chlorination system) as per Evaluation Criteria based on Marking Pattern

1. Check list of marking pattern for enlistment of vendors of **Vacuum Feed Chlorinators (chlorination system)** to be used in water supply schemes/ projects of PHED, Rajasthan along with **Annexure A (Mandatory Criteria)** , **Annexure B** and **Annexure C** is now available on departmental website as "**Form M-15**".
2. Vendors who are manufacturer of **Vacuum Feed Chlorinators (chlorination system)** have to download the **Form M-15**. They have to check and fill the form and **enclose correct adequate documents required as per Annex. A** (Mandatory Criteria) & B of **Form M-15** as applicable. All the documents required in **Annex. A** (applicable) are compulsory to qualify the eligibility for further evaluation.
3. During scrutiny, mandatory criteria i.e **Annexure A** will be checked first.
 - a) The applicant full filling all the mandatory criteria (applicable), shall only be eligible & considered for further evaluation. The documents submitted as per Annex. 'B' (Form M-15) will be examined and marks will be allotted accordingly.
 - b) If applicant is eligible w.r.t. mandatory criteria (Annexure A) and visit to manufacturing unit will be decided then Annex. 'C' (Form M-15) will be applicable.
 - c) Marking of Part A and Part B of Annex. 'C' (Form M-15) will be on the basis of document submitted & subsequently verified during shop survey.
 - d) Marking of Part C of Annex. 'C' (Form M-15) will be as witnessed, during shop survey.
 - e) In case, applicant does not full fill any of the mandatory criteria (applicable), then the applicant shall not be considered for further evaluation and informed accordingly.
4. Minimum qualifying marks will be 75%. The vendor securing marks 75% or more in evaluation as per annexure "B" or "C" as the case may be, will be considered as recommended for approval for **Vacuum Feed Chlorinators (chlorination system)**.
5. Technical Committee of the department will be the final approving authority.

6. After approval of Technical Committee the Name of vendor / Make of vendor will be added to "List of Specified Makes" of the department and vendor will be informed accordingly.

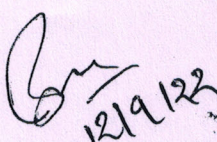
NOTE: 1. Evaluation of new submission for enlistment of vendors for **Vacuum Feed Chlorinators (chlorination system)** is now being done on the basis of marking pattern as approved by TC/ 727 dated 29.08.2022. Already approved vendors of **Vacuum Feed Chlorinators (chlorination system)** as per "List of Specified Makes" updated up to 31.12.2021 will also be reviewed periodically and subsequently based on the new evaluation criteria (i.e. marking pattern).

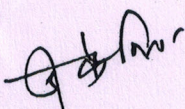
