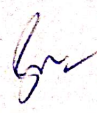


Guidelines for Enlistment of Vendors/ Manufacturers of Low Voltage Switchgear & Control gear Panels (LT Panels) to be used in water supply schemes/projects of PHED Rajasthan as per Evaluation Criteria based on Marking Pattern

1. Vendors who are manufacturer of **Low Voltage Switchgear & Control gear Panels (LT Panels)** have to download and fill the Enlistment form and enclose documents required thereon.
2. Check list of marking pattern for enlistment of vendors of **Low Voltage Switchgear & Control gear Panels (LT Panels) upto 160 Amp. (Any Panel builder matching the criteria can apply)** to be used in water supply schemes/ projects of PHED, Rajasthan along with **Annexure A-1(Mandatory Criteria) , Annexure B-1 and Annexure C-1** is now available on departmental website as **"Form M-7.1"**.
3. Check list of marking pattern for enlistment of vendors of **Low Voltage Switchgear & Control gear Panels (LT Panels) above 160 Amp. and upto 450 Amp. (Any Panel builder matching the criteria can apply)** to be used in water supply schemes/ projects of PHED, Rajasthan along with **Annexure 2 (Mandatory Criteria) , B-2, C-2**, is now available on departmental website as **"Form M- 7.2"**.
4. Check list of marking pattern for enlistment of vendors of **Low Voltage Switchgear & Control gear Panels (LT Panels) above 450 Amp. (Only OEM & Licensee Partner of PHED Rajasthan approved OEM are eligible to apply)** to be used in water supply schemes/ projects of PHED, Rajasthan along with **Annexure A-3 (Mandatory Criteria) , B-3, C-3**, is now available on departmental website as **"Form M- 7.3"**
5. Vendors / manufacturer of various types of **Low Voltage Switchgear & Control gear Panels (LT Panels)** have to download Form M-7.1, M- 7.2 or/ and Form M-7.3 as applicable to them. Vendors have to check and submit the documents required as per Annex. A-1, A-2 or A-3 (Mandatory Criteria), B-1, B-2 or B-3 of **Form M-7.1, M-7.2 or M-7.3 respectively** as applicable.
6. During scrutiny, **mandatory criteria i.e Annexure A-1, A-2 or A-3** will be checked first, in each case of Form M-7.1, M-7.2 or/and Form M-7.3.
 - a) The applicant full filling all the mandatory criteria (applicable), shall only be eligible & considered for further evaluation. The documents submitted as per Annex. 'B-1, B-2' or/and 'B-3" (Form M-7.1, M-7.2 or/and Form M-7.3 respectively), will be examined and marks will be allotted accordingly.



- b) If applicant is eligible w.r.t. mandatory criteria (Annexure A-1, A-2 or A-3) and visit to manufacturing unit will be decided then Annex. 'C-1, C-2' or/and 'C-3' (Form M-7.1, M-7.2 or/and Form M-7.3 respectively) will be applicable.
- c) Marking of Part A and Part B of Annex. 'C-1, C-2' or/and 'C-3' (Form M-7.1, M-7.2 or/and Form M-7.3 respectively) will be on the basis of document submitted & subsequently verified during shop survey.
- d) Marking of Part C-1, C-2' or/and 'C-3' (Form M-7.1, M-7.2 or/and Form M-7.3 respectively) will be as witnessed, during shop survey.
- e) In case, applicant does not full fill any of the mandatory criteria (applicable), then the applicant shall not be considered for further evaluation and informed accordingly.
7. Minimum qualifying marks will be 75%. The vendor securing marks 75% or more in evaluation as per annexure 'B-1/ B-2'/'B-3" or "C-1/ C-2'/'C-3" as the case may be, will be considered as recommended for approval for that type of LT Panel.
8. Separate sheet will be prepared for each type of LT Panel
9. Technical Committee of the department will be the final approving authority.
10. After approval of Technical Committee the Name of vendor / Make of vendor will be added to "List of Specified Makes" of the department and vendor will be informed accordingly.

NOTE: Evaluation of new submission for enlistment of vendors for **Low Voltage Switchgear & Control gear Panels (LT Panels)** will be done on the basis of marking pattern as approved by TC/ 772 dated 02.04.2025. Already approved vendors of LT Panels, as per "List of Specified Makes" updated up to 01.08.2024 (Col. 2) will also be reviewed periodically and subsequently based on the new evaluation criteria (i.e. marking pattern).
