Modified Eligibility Criteria for approval of vendors of DI Pipes for

Drinking Water

Only manufacturers of DI Pipes are eligible to apply for enlistment / vendor approval

Manufacturers have to submit following documents for enlistment / vendor approval in PHED, Rajasthan (please read carefully and enclose supporting document/s wherever required)

All Documents are Mandatory

1	Registration Certificate of Firm (Registered in INDIA):- Company registration certificate and Memorandum & Article of Association issued by Registrar of Company / Partnership deed / Sole proprietorship deed issued by competent authority
2	Registration of Manufacturing unit (situated in INDIA) :- Registration Certificates of manufacturing unit , issued by DIC / ministry of commerce & Industries, govt. of India or any other competent authority clearly mentioning type of unit, such as Micro/ Small/ Medium / Large scale industrial unit OR Udyog Aadhar OR Factory License issued by competent authority
3	Valid BIS licence for DI Pipes available with vendor as per IS: 8329: 2000, clearly mentioning the type (K7, K9 etc.) and size licensed for manufacturing.
4	ISO 9001:2015 Certificate. Quality Management System
5	ISO 14001:2004 Certificate. Environment Management System
6	ISO 18001:2004 Certificate (OHSAS) / ISO 45001, Occupational Health & safety management System
7	GST Registration Certificate
8	Income Tax Permanent No.
9	Import & Export License issued by Ministry of Commerce & Industry- Government of India
10	Turnover of the firm in last FY (Min. 250.00 Crores). Relevant portion of audited balance sheet must be submitted.
11	Details of In-House - Induction furnace.
12	In-House testing facilities available for Routine tests for the product as per applicable BIS code. (sample routine test reports should be enclosed)
13	Potable water compliance certificate for the material used for inner lining of the pipe
14	Potable water compliance certificate for Rubber Gasket used in Push-on-joints or any mechanical joints of the pipe, come in contact with drinking water

15	Manufacturer has to submit an undertaking on Non-Judicial stamp paper worth Rs. 100/- that (i) (a) The Firm has not been Black-Listed by any department of the Central Government/ any State government, in last <u>2</u> years. (b) The Firm has not been De-barred by any department of Government of Rajasthan, in last <u>2</u> years. (c) The Firm has not been convicted of an offence- under the prevention of Corruption Act, 1988 (Central Act No 49 of 1988). (d) The Firm has not been convicted of an offence- under the Indian Penal Code, 1860 (Central Act No 45 of 1860) or any other law for time being in force, for causing any loss of life or property or causing a threat to public health as part of execution of a public procurement contract. (ii) Their BIS license has not been put on STOP marking/ suspension/ cancellation on the date of submission of application.
