Transfer of Environmental Clearance

Environmental Clearance to Sh. Rahul Pandey was granted for Mining Lease No. 1511/90 for mineral Baroda Marble near village- Baroda, Tehsil- Salumber, District- Udaipur (Raj.) (**Proposal No-134680**), vide SEIAA letter dated 27.04.2016. Sh. Kailash Chandra Gadiya (PP) had submitted application dated 27.05.2020 for transfer of EC from Sh. Rahul Pandey S/o. Shri Ramesh Chandra Pandey to Sh. Kailash Chandra Gadiya S/o.- Shri Ram Chandra Gadiya. Due to death of Sh. Rahul Pandey the lease was mutated to his wife Smt. Aarti Pandey vide letter dated 14.11.2017. Later on lease was transferred to Sh. Kailash Chandra Gadiya, S/o. Shri Ram Chandra Gadiya vide letter dated 24.03.2018. The PP has submitted report dated 06.11.2020 of the RO of the RSPCB, Udaipur regarding verification of conditions of earlier EC. Smt. Aarti Pandey W/o Late Sh. Rahul Pandey (transferor) has submitted affidavit dated 16.11.2019 stating that they have no objection to transfer of EC to Sh. Kailash Chandra Gadiya, Sh. Kailash Chandra Gadiya.

The SEAC, after thorough appraisal of the project and having regard to the information contained in Form-1, Form-2 and other documents submitted by the PP and presentation made by his consultant, resolved to recommend to SEIAA for transfer of EC granted by SEIAA vide letter dated 27.04.2016 from Sh. Rahul Pandey S/o. Shri Ramesh Chandra Pandey to Sh. Kailash Chandra Gadiya S/o.- Shri Ram Chandra Gadiya for M.L. No.-1511/90, Area-1.0756 ha., Production Capacity- 3500 TPA of Mineral Marble, (**Proposal No-134680**), subject to compliance of the conditions imposed by SEIAA vide letter dated 27.04.2016, with the specific and general conditions annexed at Annexure 'A'.

The matter of transfer of environment clearance was considered in the 4.47th meeting of SEIAA and the Authority has accepted the recommendation of SEAC.
