The issue regarding exemption from requirement of boundary wall around premises of stone crushing units was raised during the stakeholders seminar held in RSPCB, Head Quarter on 18.02.2020. The issue has been examined vis-à-vis provisions of the Air(Prevention & Control of Pollution) Act, 1981 and Environment(Protection) Act, 1986 and the State Board's existing guidelines for Stone Crushers, and a partial modification to "Guidelines for Abatement and Control of Pollution in Stone Crusher Industry" issued vide State Board's Order No. SCMG & DS/ RPCB/Gen-3/ 307 dated 05.06.2018, the last Bullet Point of Para No. 2 at Page No. 6 of the guidelines is hereby substituted with the following paragraph:-

 "The stone crusher unit shall provide boundary wall or wire fencing or any other suitable practice may be adopted to identify/demarcate land area under possession of the unit."
