G.S.R.102 .-In exercise of the powers conferred by section 54 of the Air (Prevention and Control of Pollution) Act, 1981 (Central Act No. 14 of 1981), the State Government, after consultation with the Rajasthan State Pollution Control Board, hereby makes the following rules further to amend the Rajasthan Air (Prevention and Control of Pollution) Rules, 1983, namely:-

1.Short title and commencement.- (1) These rules may be called the Rajasthan Air (Prevention and Control of Pollution) (Amendment) Rules, 2022.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

2.Amendment of SCHEDULE.- In part-IV of the SCHEDULE appended to the Rajasthan Air (Prevention and Control of Pollution) Rules, 1983, after the existing serial number 47 and entries thereto, the following new serial numbers 48 to 54 and entries thereto shall be added, namely:-

G.S.R.101 .-In exercise of the powers conferred by section 64 of the Water (Prevention and Control of Pollution) Act, 1974 (Central Act No. 6 of 1974), the State Government, after consultation with the Rajasthan State Pollution Control Board, hereby makes the following rules further to amend the Rajasthan Water (Prevention and Control of Pollution) Rules, 1975, namely:-

1.Short title and commencement.- (1) These rules may be called the Rajasthan Water (Prevention and Control of Pollution) (Amendment) Rules, 2022.

(2) They shall come into force on and from the date of their publication in the Official Gazette.
