It has been noted that despite office order No.- SCMG (Gen-3)/ RPCB/ 55- 103 dated 21.04.2015, the applications forwarded by Regional offices of Stone Crushers are not complete in all respect which leads to delay in disposal of consent applications.

The Regional offices while forwarding application or sending verification report in cases of Stone Crushers shall ensure that:-

- 1. That application is completely filled and all enclosures as per check list of documents are enclosed.
- 2. The documents as required at the time of Consent to Establish as per check list of documents shall also be enclosed while forwarding Consent to Operate applications.
- 3. The deposition of fees and its adequacy.
- 4. The reasons of earlier refusal/ directions and rectification of same by units.
- 5. Compliance of directions (if issued) including disconnection of electricity.
- 6. The date of first grant of Consent to Establish/ Operate and compliance of guidelines prevalent at that time including distance certificate obtained at that time.
- 7. The inspection reports as per format prescribed in Operating Manual.
- 8. The comments on status of legal case, if any, with especial reference to its implication on disposal of consent application.
- 9. Clear cut recommendation on grant/ refusal of application.
