Office Order

Central Pollution Control Board had issued directions dated 09.10.2025 regarding the installation of OCEMS in industrial units of three sectors i.e. Metal, Textile, Food & food processing located in the NCR region of Rajasthan.

As per these directions, in case of metal industries, OCEMS shall be installed for monitoring of PM, SO₂ and NO_x parameters in all furnaces using met-coke, LSHS/ultra or very low sulphur oil as fuel. For the remaining Metal industries, OCEMS shall be installed for the monitoring of the PM parameter only. Further, PTZ camera shall be installed as per the SOP mentioned in the aforesaid directions.

In compliance of above directions, the State Board has issued directions to the concerned industrial units as per the list provided by CPCB.

Subsequently, a representation was received from Lead Recycling units having temple furnaces located in Alwar district, seeking exemption from installation of OCEMS for SO₂ and NO_x parameters in their Temple furnaces using wood charcoal as fuel. The Commission for Air Quality Management (CAQM) has permitted the use of wood charcoal as fuel for Lead Recycling units vide letter dated 10.10.2022.

The matter has been examined, and in accordance with CPCB's directions dated 09.10.2025, it is hereby clarified that:

1. Furnaces in Lead recycling units (Temple/Rotary) using wood charcoal/Gas as fuel are required to install OCEMS for the PM parameter only.
2. Furnaces in Lead recycling units (Temple/Rotary) using LSHS as fuel are required to install OCEMS for PM, SO₂ & NO_x parameters.
3. PTZ camera shall be installed in all cases as per the SOP mentioned in the aforesaid CPCB directions.

Further, all such industries located in the NCR region of Rajasthan are directed to ensure installation and complete configuration of OCEMS for the applicable parameters, along with data connectivity and transmission to CPCB's ODAMS Portal and the State Board servers.
