## Office Order

F.14 (5)Adm/RPCB/Plg/

As per prevalent practice in the State Board, Regional Officers revoke the Consent to Operate and Authorization of the units under their jurisdiction at their level. The matter has been examined in detail and it is decided that henceforth all matters of revocation of Consent to Operate/ Authorization shall now be dealt at RSPCB Head Quarter level only and would be done only after due approval of the Chairperson, RSPCB.

The procedure and steps for revocation of Consent to Operate/ Authorization shall be exactly similar to the procedure being followed in the State Board for issuance of closure directions to any Industry/Project/ Health Care Facility /Activity/Process etc. as under section 33 (A)/ 31 (A) or the relevant provisions of Rules/ Acts.

In case, wherein the non-compliances of CTE/CTO/Authorization are so grave that in the opinion of the Regional Officer it mandates revocation of CTE/CTO/Authorization and so also, in all cases of grave damage being caused by the unit to the environment where the Regional Officer deems it fit that the Consent/ Authorization should be revoked to prevent further damage to the environment, in all such cases the Regional Officer shall submit the case to RSPCB, Headquarters along with clear recommendations for revocation of Consent/ Authorization. The matter should be sent with all relevant documents i.e Inspection Report, Water sampling report, Air monitoring report(if sampling or monitoring done), photographs etc. along with evidence based reasons/recommendations.

The delegation of power to Grant and Refuse applications for Consent to Establish, Consent to Operate and Authorization under relevant Acts would continue to be with the Regional Officers as per State Board's office order no. F14/(23)Policy/ Planning/ VI/ 2335-2372 dated 29.03.2018 and all related subsequent orders issued by the Board from time to time.

This bears approval of the competent authority.
