### OFFICE ORDER

In partial modification to office order no. F.14(23) Policy/RSPCB/Plg/10588-10631 dated 07/03/2013 , the power to dispose cases for grant or refusal of consent to establish/operate under the provision of the Water (Prevention and Control of Pollution) Act, 1974/Air (Prevention and Control of Pollution) Act, 1981 delegated to Regional Office under their territorial jurisdiction w.r.t. to following sectors are withdrawn, and now these will be decided at Head Office level.

1. Fertilizer (Granulation and Formulation only)
2. Formulation/ paletization of camphor tablets, naphthalene balls from camphor/naphthalene powders
3. Pharmaceutical formulation and for R&D purpose (for sustained release/extended release of drugs only and not for commercial purpose)
4. Formulation of pesticides, agro chemicals and so on

This order shall come into force with immediate effect.
