## SOP

## Clarification regarding status of installation/ connectivity of OCEMS and submission of Bank Guarantee in the matter, regarding.

All the 17 Category of Highly Polluting Industry and CTDF have been earlier directed regarding installation and connectivity of Online Continuous Emission/Effluent Monitoring System (OCEMS) with CPCB and RSPCB servers up to 30.06.2015 in compliance of CPCB directions dated 05.02.2014 and 02.03.2015. Further, these industries were also directed to submit stipulated Bank Guarantee (BG) prescribed under the directions issued by the State Board therein and subsequent correspondences. Further State Board had extended deadline of installation of OCEMS upto 30.09.2015.

The State Board has reviewed the status of installation/ configuration of OCEMS along with submission of stipulated fee/BG related to OCEMS. It has been observed by the Board that despite delayed installation of OCEMS some of the industries have failed to submit the stipulated BG or submitted deficit amount of BG. Therefore in order to maintain uniformity for all the industries covered under the aforesaid CPCB directions, following procedure w.r.t. submission of bank guarantee for industries covered under the purview of OCEMS installation will be adopted:-

- Industries which have installed and connected any of the requisite analyzers for OCEMS as per CPCB directions from 30.09.2015 to date of issuance of this SOP and fully complied CPCB/ RSPCB directions are directed to submit equivalent amount of non-refundable Demand Draft (against BG) for the cost of such analyzers installed after 30.09.2015 to until date of issuance of this SOP. In case of industries that have submitted equivalent amount of BG or deficit amount of BG are directed to submit the entire amount of BG in the form of non-refundable Demand Draft. State Board shall return the BG submitted earlier by these industries.
- (ii) Industries that have installed and connected all the requisite analyzers for OCEMS as per CPCB/RSPCB directions till date of issuance of this SOP and submitted BG of 150% cost of OCEMS are directed to submit non-refundable Demand Draft (against BG) of equivalent of 100% cost of OCEMS installed after 30.09.2015 to date of issuance of this SOP. Board shall return the BG submitted earlier by these industries.
- (iii) For industries that have installed and connected all the requisite analyzers for OCEMS as per CPCB directions till date of issuance of this SOP and submitted equivalent amount of demand draft against BG of 150% cost of OCEMS, 50% amount shall be returned back to all such industries by the State Board.
- (iv) Any of the industry that have not installed and connected OCEMS as per CPCB/ RSPCB directions till date are directed to ensure installation of all requisite parameters and configure with CPCB/ RSPCB servers by 30.03.2021 and submit non-refundable Demand Draft (against BG) of 150% cost of OCEMS to be installed. Please note that no further time extension will be given for installation of the OCEMS.

- (v) BG/DD Amount shall be verified on the basis of purchase orders of OCEMS and request letter/email which was sent by the industry to State Board for connectivity with the State Board's OCEMS portal.
- (vi) All the covered industries are directed to ensure submission of fee for connectivity with OCEMS portal as per State Board office order no F.11 (495) RPCB/Lab/1964 dated 27.12.2017.

All the industries covered under CPCB directions of OCEMS are directed to comply with the above direction and submit compliance to this office by 28.02.2021 failing which the State Board shall initiate legal action against the industry and its occupiers under the provisions of the Air Act and the Water Act. All Group In charges/ Regional Offices are directed to ensure compliance of the above in the industries covered under CPCB directions of OCEMS in their jurisdiction.

Further, all Group In charges/ Regional Offices are directed to review the list of industries in their jurisdiction that have not been directed by the State Board earlier to carry out necessary installation/ configuration of OCEMS but may fall under this purview as per CPCB guidelines.
