CIRCULAR

State Board vide its Circular dated 24.02.2023, had laid down procedure for disposal of consent applications in case of Gold Assaying and Hallmarking Centres (GAHCs). Further Department of Environment and Climate Change, Government of Rajasthan vide letter dated 25.07.2023, has directed the State Board to dispose consent applications with specific directions mentioned therein.

In supersession to State Board Circular dated 24.02.2023, it is directed that:

1. Those GAHCs be considered existing which is functional on ground on the date of application for consent.
2. Even at places where master/ city plans exist, GAHCs in areas largely used as market/ for commercial activities, permission to grant consent be given without insisting on land conversion.
3. Further, CTE/ CTO applications may be granted to GAHC to operate without any condition of land conversion in cities having no clear city/ master plans, provided these units are in local market place/ bazaar where other commercial activities are being carried out.

In view of above, all Regional Officers, RSPCB are directed to dispose consent applications of GAHCs.
