Office Order

F.06(16)AR/Gr-3/2019/Part-06378 & having Raj Kaj reference No. 5706864. The Rajasthan State Pollution Control Board is made Nodal Department.

The Department of Environment vide letter no. F.10(3)/Forest/2024 dated 23/02/2024 and Raj Kaj reference No. 58850441 has directed to:-

- Organize a meeting in coherence with the HE governor to decide the future policy and roadmap.
- ii) To take any and all action being a Nodal Agency.

In compliance of above a "Green War Room" is created at the Head-quarter of Rajasthan State Pollution control Board, Jaipur which will be headed by Chief Environmental Engineer and will be assisted by :-

- i) Sh. Arvind Agarwal, SEE,
- Sh. Surendar Verma, Superintendent SO
- iii) Sh. Ankur Pathak, EE
- iv) Smt. Divya Sharma, SO
- Sh. Rakesh Choudhary, JEE.

Planning cell will remain the Nodal Section.

The terms & reference of Green war room will be:-

- In case of reports of any serious issue of Pollution, the same will be get investigated and recommendations will be made.
- ii) The Green War Room will be vigilant towards any recurring causes of Pollution and whenever there is requirement of any policy changes/ intervention, will put up with recommendations.
- iii) Monitor Data of OCEMS and action taken by concerning cells/ Regional Officers in case of exceedance.
- Monitor Data of CAAQMS, prepare Graded Action Plan & make recommendations iv) accordingly.

- The data from an early warning system for Jaipur developed in collaboration of Indian Institute of Tropical Meteorology Ministry of Earth Sciences, Govt. of India, will be analyzed and recommendations will be made for actions to prevent/reduce impact during exceed forecast.
- vii) The committee will recommend and get studies conducted by reputed agencies wherever need is felt.
- viii) The committee will also review findings of important studies including source apportion studies and submit Meteorology for adopting mitigation measures.
- Review time to time existing policies related to environmental laws, its ix) implementation and if found required submit proposals for required change in existing policies and policy intervention.
- The committee will prepare a note agenda for review by the committee constituted x) under Additional Chief Secretary, and organize meeting at least once in three months.

The OCEMS Cell and Air Quality Management Cell, RSPCB will work under instruction and co-ordination with Green War Room.
