Office-Order

Central Pollution Control Board (CPCB), has developed a new OCEMS portal (namely ODAMS) having features such as direct transmission of data from industries to CPCB servers without any dependency on TDPS, PTZ camera integration, data analytics and visualization, revised calibration protocol implementation, geotagging, alerts based on revised OCEMS alert protocol etc. The new OCEMS portal has been made live on 31.08.2025.

All Industries/common facilities with OCEMS connectivity are required to register and connect to new OCEMS portal by filling the required details, including location coordinates, categorization, classification, station information, analyzer information etc. at https://cems.cpcb.gov.in The procedure to register on the new portal is also available on the aforesaid URL.

Further, CPCB has issued directions to State Board under section 18(1) (b) of the Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 in the matter of onboarding of industries to new OCEMS portal of CPCB.

In compliance of above directions, all industries, that have installed OCEMS or require to install the same are directed to register and connect to new OCEMS portal **OCEMS Portal** Link-New through the link, **CPCB** of https://cems.cpcb.gov.in/#/p/login as per the timelines given below: -

- a. For industries located in NCR-Delhi latest by 15.10.2025
- b. For all other industries latest by 15.11.2025

All industries under purview of OCEMS directions issued by CPCB time to time shall ensure the compliance of the above directions within stipulated time and submit the details of the registration on onlinemonitoring.rpcb@gmail.com without fail. Further, any issue related to registration, the units may communicate with CPCB for clarification.
