Implementation of online module for submission of Registration applications under Plastic Waste Management Rules, 2016 (amended in 2018)

Registration for Producer/Brand Owner, Recycler and Manufacturer of Raw materials is required to be obtained from Rajasthan State Pollution Control Board under the provisions of Plastic Waste Management Rules, 2016 (amended in 2018).

The Rajasthan State Pollution Control Board has developed the system for online submission of the applications for Registration under Plastic Waste Management Rules, 2016 (amended in 2018) along with requisite documents (www.environment.rajasthan.gov.in/rpcb). It is directed that:

- (i) Henceforth, all the applications for Registration under Plastic Waste Management Rules, 2016 (amended in 2018) shall be submitted through online module only, and no offline applications for Registration under Plastic Waste Management Rules, 2016 (amended in 2018) shall be accepted.
- (ii) Project Proponents will ensure submission of requisite information and attachment/upload of necessary documents before final submission of online applications.
- (iii) No processing/ Registration fee is required to be paid by Project Proponent with Registration applications under Plastic Waste Management Rules, 2016 (amended in 2018)
- (iv) All applications for the renewal of Registration under Plastic Waste Management Rules, 2016 (amended in 2018) shall be made online before one hundred and twenty days of its expiry, mandatorily.

This order shall come into force with immediate effect.
