Office Order

The State Board reviewed the existing scenario w.r.t. the analysis report formats currently in use for reporting the analysis results of water, wastewater, ambient air, fugitive emissions, process emissions, stack emissions, ambient noise, source noise, soil, sludge, sediments, solid waste and hazardous waste samples.

In this regards, it has been observed that there is an imperative need to update the existing formats and design a new format (wherever required) for reporting analysis results pertaining to the above mentioned samples with complete inclusion of the details as prescribed in the provisions of Water Rules, 1975 and Air Rules, 1983 read with Rajasthan Water Rules and Rajasthan Air Rules (wherever applicable).

Also there is a requirement to cover reporting of noise monitoring in the reporting format prescribed under Air Rules (as noise is considered pollutant under Air Act, 1981). Additionally, in the absence of any defined format for soil, sludge, sediments, solid waste and hazardous waste samples, the State Board has taken steps to design and adopt a new reporting format. The requirements of ISO/IEC 17025: 2017 Accreditation have also been incorporated as major State Board Laboratories are already accredited in accordance to this International Standard.

Therefore, the following updations/adoption have been decided in order to improve the quality of reporting of results in consideration of the compliances under relevant Acts/Rules and ISO/IEC 17025: 2017 Accreditation: -

- The existing format of water, wastewater analysis report as prescribed in the Water Rules i.e. Form-X has been updated for adoption in all State Board Laboratories (Annexure-A).
- The noise monitoring/analysis report shall be released under the aegis of Air Rules, 1983.
- The existing format of ambient air, fugitive emissions, process emissions, stack emissions including ambient noise, source noise analysis report as prescribed in the Air Rules i.e. Form-IV has been updated for adoption in all State Board Laboratories (Annexure-B).

- In case a sample analysed for accredited as well as for non- accredited parameters, the analysis report shall be issued in two continual parts: - **one** with NABL logo for accredited parameters and **another** without NABL logo for non-accredited parameters.
