Office-Order

Hon'ble National Green Tribunal in the matter of Original Application No.34/2014(THC) Digvijay Singh V/S State of Rajasthan & Others has in its order dated 06.03.2019 directed that no further new industries particularly which generates trade effluent should be allowed by Rajasthan State Pollution Control Board till existing industry meet the prescribed effluent standards in the Balotra, Bithuja and Jasol.

In compliance of Hon'ble NGT direction, the State Board issued an office order vide letter no. F14(Gen-3)/Tech/RSPCB/Plg/21-CETP/35-45 dated 02.04.2019 that no Consent to Establish will be issued to any new industry or CTE for expansion of any existing industrial unit which generates trade effluent.

Hon'ble National Green Tribunal has disposed of OA No. 34/2014- Digvijay Singh Vs State of Rajasthan & Ors, OA No. 329/2015 - Villagers of Gram Panchayat Araba Vs State of Rajasthan & Ors and OA No. 32/2014-Kishan Paryavaran Sangharsh Samiti Vs. State of Rajasthan & Ors by passing a common order on 25.02.2022 and one of the directions given by the Hon'ble NGT is as under:-

"Immediate efforts are to be made to use the full utilization capacity of those CETPs which are underutilized currently".

The CETP at Balotra has installed facility to treat and maintain ZLD status for trade effluent of 18 MLD & Consent to Operate has also been issued to the CETP to treat trade effluent upto 18 MLD vide order no. 2022-2023/Liquid Waste/1295 dated 12.05.2022, which is valid till 31.07.2026.

Thereafter, the matter has been re-examined and the State Board office order dated 02.04.2019 is partially modified to the extent that Balotra is deleted from coverage of

In order to comply with NGT order dated 25.02.2022 and to use 100% capacity of CETP, establishment of new units and expansion of existing units in Balotra is permitted subject to following conditions:-

- (a) That the total trade effluent by member units discharging to CETP shall not exceed 18 MLD.
- (b) CETP, Balotra Trust shall submit a list of industries with allotted trade effluent duly approved by the District Monitoring Committee to the State
- (c) Units shall apply for Consent to Establish and Consent to Operate as the case may be with a valid certificate of allowed trade effluent by CETP Trust.
