OFFICE ORDER

All the Health Care Facilities are required to obtain Consent to Establish and Consent to Operate under the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981. Further, the Health Care Facilities (HCFs) are also required to obtain authorization under the Bio-medical Waste Management Rules, 2016.

State Board has been processing Authorization and Consent to Operate (ACTO) applications from the health care facilities, concurrently. The State Government has notified consent fee for Consent to Establish (CTE) and Consent to Operate (CTO) vide notification dated 26.05.2016, and there is no separate fee for authorization under Bio-medical Waste Management Rules, 2016.

Further, as per the fee notification dated 26.05.2016, Hospitals, Nursing Homes and Health Care Establishments up to 10 beds, Non-bedded Health care facilities (clinics, Pathological/ Forensic/ Research Laboratories and Blood Banks, Veterinary Institution, Dispensaries and Animal Houses, Drug vendor/ drug ware houses) are required to obtain one time Consent to operate. Accordingly, State Board has been granting one time authorization and consent to operate to such Health Care Facilities (non-bedded and up to 10 beds).

It has been observed that in a few cases, Health Care Facilities (non bedded and up to 10 beds) have been issued authorization and consent for five years instead of one time Authorization and Consent to Operate. In view of the above, it has been decided that authorizations and consents issued to the Health Care Facilities (non bedded as well as up to 10 beds) after 26.05.2016 wherein Authorization and Consent to Operate has been granted for 5 years only, shall be considered as valid without any time limit until any change in bed capacity and other services.

This bears approval of the competent authority.
