Office Order

The State Board has issued order dated 29.12.2023, 13.04.2024 & 07.03.2025 to specify requirement of Sewage Treatment Plants for the Health Care facilities. Accordingly, all the Health Care Facilities discharging waste water into public sewer connected to a terminal Sewage Treatment Plant (except the HCFs having more than 100 beds or connected with Medical College / Educational Institutions or require Environmental Clearance as per EIA notification) need not install their own STPs subject to submission of certificate / letter to this effect duly issued by the competent authority (i.e. Municipal Body / Development Authority / Panchayat etc.)

In view of the above and in continuation to the State Board Order No. F.12(5-Adm)RPCB/Gen/1693-1702 dated 28.08.2023, regarding the checklist of documents to be submitted with applications for Consent to Establish / Operate / Authorization / Registration, it is hereby directed that submission of Certificate / letter duly issued by the competent authority (i.e. Municipal Body / Development Authority / Panchayat etc.) related to effluent disposal shall now onwards will be considered as a mandatory requirement at the pre-screening stage for Consent to Operate/Authorization applications of such Health Care Facilities (HCFs).

This order shall come into force with immediate effect.
