Office Order

In supersession of all orders and directions issued by this office, relating to mandatory plantation and plantation related conditions, in reference to project/ units which have obtained valid Environmental Clearance from SEIAA, the following shall be applicable for their consent/ authorisation granted under the provisions of Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981.

1. **Incorporation of EC Conditions:**

The Rajasthan State Pollution Control Board (RSPCB) shall incorporate a general condition in the Consent/Authorization to ensure compliance of all conditions of the Environmental Clearance (EC) granted by the competent authority. Accordingly, the Board shall not impose separate or repetitive conditions relating to plantation where such requirements are already mentioned in the EC.

2. **Applicability:**

This provision shall be applicable to all categories of projects, including Building and Infrastructure projects.

3. **Industrial Areas Requiring EC:**

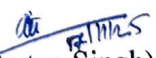
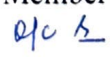
In case of Industrial Areas where EC is applicable, the plantation criteria shall be considered holistically for the entire industrial area.

- The developer of the industrial area shall be responsible for carrying out the requisite plantation as per EC/approved plan.
- If the developer opts not to undertake the plantation on its own, it may deposit the equivalent plantation cost to the SFDA account of the Forest Department.
- The developer may recover the proportionate amount deposited towards plantation cost from individual member units at the time of allotment of plots.

4. **Implementation:**

The concerned Group-In-Charges and Regional Officers shall ensure compliance of the above decision.
