Office Order

The Hon'ble National Green Tribunal, Central Zonal Bench, Bhopal in the Original Application No. 158/2016, Naveen Sarawat V/s State of Rajasthan & Ors. has passed order on 20.03.2017 that the office order dated 17.11.2015 shall be kept in abeyance with immediate effect. Subsequently by the order dated 23.05.2017 the Hon'ble NGT has passed order that the office order dated 17.11.2015 which was kept in abeyance is ordered to be vacated.

In view of the orders of the Hon'ble NGT, the consent applications may be disposed of with the condition that the project proponent/industry shall submit receipt of application for abstraction of ground water from CGWA within a period of 30 days positively and thereafter shall obtain NOC within further six months, failing which the consent shall deemed to be revoked.
