ORDER

It has been observed that own ETP units situated at Balotra district are not operating their ZLD systems (RO, MEE, MVR, ATFD etc.) in effective and proper manner to achieve complete ZLD status. Further, operation and maintenance of ETP and ZLD need to be improved for scientific treatment of effluent and recycling of treated waste water in the process, up to maximum extent.

In order to ensure strict compliance of the conditions imposed in valid Consent to Operate accorded by the State Board and provisions of the Water (Prevention and Control of Pollution) Act, 1974, all the industries of Balotra district having their own ETP and ZLD plant are hereby directed to ensure compliance with respect to following observations and submit compliance report to Regional Office, RSPCB, Balotra latest by 28.02.2026:

- (i) Ensure adequate metering arrangements at suitable locations of ETP and ZLD lines and maintain proper logbook for quantity of effluent intake, treated waste water from ETP, recycled waste water (RO & MEE) and quantity of reject water.
- (ii) Enhance capacity of ZLD plant in coherence with ETP's capacity.
- (iii) Ensure regular operation of ZLD units i.e. RO, MEE & ATFD and maintain record for the same along with records of electricity and coal/fuel consumption.
- (iv) Install adequate scientific arrangements for handling MEE residue.
- (v) Remove flexible pipelines from all segments of ETP and ZLD.
- (vi) Discontinue the practice of storage of untreated effluent in Solar Evaporation Pans/Kaccha Pits/Holding tank.
- (vii) Obtain authorization under Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016, immediately.
- (viii) Provide safe earmarked storage site for hazardous waste.
- (ix) Upgrade/maintain air pollution control measures at all emission sources to ensure compliance with the standards prescribed under MoEF & CC notification dated 16.05.2023.
- (x) Block all outlets/drains of the unit towards adjoining nallah/river/drain.
- (xi) Transmission of data (>85%), where OCEMS is installed.

Henceforth, pending Consent to Operate applications of own ETP units located in Balotra district shall be considered after verification of above mentioned observations. The existing units shall submit an action plan to rectify the above non-compliances latest by 28.02.2026, without fail. Regional Officer, RSPCB, Balotra is hereby directed to keep vigil on these units and ensure compliance of the above mentioned observations and submit consolidated compliance status to Headquarter in first week of March, 2026.

This bears approval of the competent authority.
