## Order

In partial modification of all previous orders issued regarding delegation of power to Regional Officers, the power to grant, refuse and revoke Consent to Establish/Consent to Operate under the provisions of the Water (Prevention & Control of Pollution) Act, 1974 and/or Air (Prevention & Control of Pollution) Act, 1981, Authorization & Passbook under the Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016 and Authorization under the Bio Medical Waste Management Rules, 2016 is hereby delegated to the Regional Officers of the State Board for following Orange/Red Category Industries/Projects/ Processes/Activity located within their territorial jurisdiction:-

### A. Orange category:

1.	Township and Area Development Project up to 50 Hectare (irrespective of number of dwelling units)
2.	Food & Food Processing Units including Fruits & Vegetable Processing, Food Additives (Large scale)

### B. Red Category:

1.	Mining in lease area up to 50 Hectare.
2.	Health Care Establishments up to 300 beds.
3.	Dairy and Dairy Products (Micro, Small and Medium Enterprises)
4.	Non Alcoholic Beverages (soft drink) & Bottling of Alcohol/Non Alcoholic products (Micro, Small and Medium Enterprises)
5.	Standalone biomass based power plants or captive biomass based power plants established/proposed in industries under purview of Regional Office.
6.	Small scale industries engaged in recycling/reprocessing/recovery/reuse of Hazardous waste under schedule IV of Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016
7.	Aerial Rope Way
8.	Industrial Estate/Parks/Complexes/Areas/Export Processing Zone/SEZs/Biotech Parks/Leather Complexes (except Solar and Wind Industrial Estate/Parks/Complexes having areas up to 500 Hectares).
