Order

The State Board vide its Order no F11 (93) RSPCB/ Lab/ 6056-7013 dated 09.03.2023, had issued "Guidelines for ensuring health and safety of employees carrying out Stack Monitoring in industries or other places" wherein, requirements of stack monitoring infrastructure in industries and the steps to be taken to minimize the risks associated with stack monitoring had been stipulated by the State Board.

However, it has been observed that the Guidelines issued vide order dated 09.03.2023 are not being followed during monitoring of stacks in some units and requirements of stack monitoring infrastructure in units are not complied

The matter has been reviewed, and in view of the above, it has been decided to incorporate the following mandatory condition in the consents to the units at the time of grant

"that the industry shall ensure necessary steps for effective implementation of Guidelines for ensuring health and safety of employees carrying out Stack Monitoring in industries or other places issued by the State Board vide order dated 09.03.2023".
