ORDER

Rajasthan State Pollution Control Board had issued directions under Section 33A of the Water (Prevention & Control of Pollution) Act, 1974 on 03.01.2026 to M/s Jodhpur Pollution Control and Research Foundation (SPV of CETP-Textile, Jodhpur), mandating strict implementation of the Graded Response Roster Plan (GRRP) to regulate wastewater discharge and prevent overflow from textile conduit lines. The GRRP has come into force with effect from 10.01.2026 and is now applicable to all member units connected with CETP (Textile), Jodhpur.

All member units having valid Consent to Operate and connected with CETP-Textile, Jodhpur shall be permitted to operate only at the following restricted wastewater discharge capacities, during the effective period of GRRP :

- Units having consented discharge up to 25.00 KLD:
Permitted to operate at consented capacity.
- Units having consented discharge above 25.00 KLD and up to 50.00 KLD:
Permitted to operate at a maximum of 25.00 KLD.
- Units having consented discharge above 50.00 KLD:
Permitted to operate at 50% of their consented discharge quantity.

The abovementioned restrictions shall be considered as mandatory conditions of the valid Consent to Operate accorded under Sections 25/26 of the Water (Prevention & Control of Pollution) Act, 1974 by the Rajasthan State Pollution Control Board to the member units connected with CETP (Textile), Jodhpur, during the effective period of GRRP imposed on CETP (Textile), Jodhpur. Any non-compliance of this order, if found during inspection of any member unit, may compel the State Board to initiate stern action.

This bears approval of the competent authority.
