Commissioner Industries, Government of Rajasthan has informed vide letter no. F. 33() CI/EODB/2017 dated 11/10/2017 that a Central Inspection System (CIS) has been institutionalized in reference to BRAP-2017 reform point Nos. 86,87 and 88, for streamlining the inspections of Labour, Rajasthan State Pollution Control Board and Factories & Boilers inspection Department.

It was also informed that Central Inspection System has been developed by Department of Information Technology & Communication, Government of Rajasthan on Single Window System portal http://swcs.rajasthan.gov.in to integrate the departmental inspection system with Central Inspection System (CIS) for synchronization of inspections and implementation of criteria described in Implementation Guide of BRAO-2017 for above reform points.

In continuation to office order number F. 12(PSC-1)RSPCB/PSC/473-510 dated 01/06/2016, it is hereby directed that the inspections be carried out in accordance with the Central Inspection System developed by Department of Information Technology & Communication, Government of Rajasthan.

- a. The CIS inspections shall be conducted in synchronization with Labour and/or Factories & Boilers departments wherever jointly scheduled in Central Inspection System.
- b. The scheduling of CIS inspections will be done through automated randomized manner based on computerized risk assessment by the online system.
- c. The computerized risk assessment will be done as per the risk assessment logic of the respective departments.
- d. Inspection reports shall be submitted online within 48 hours on the CIS.
- e. Same inspector shall not perform two consecutive inspections of the same industry/project/process/activity.
