OFFICE ORDER

In exercise of powers, conferred upon the State Board under the provisions of the Air (Prevention & Control of Pollution) Act, 1981, the State Board imposes standards for emission of air pollutants into the atmosphere from industrial plants, while issuing Consent to Establish and Consent to Operate to these units under the provisions of the said act.

It has come to the notice that varied standards for emission of Particulate Matter has been imposed in Rice Mills operating across the State.

In order to standardize the practice of imposition of standards and ensure uniformity across the State, it is decided that standards for Particulate Matter Emission on Rice Mill using husk/agro waste as boiler fuel, shall be prescribed as per entry no. 97 under Environment Protection Rules, 1986 reiterated below:

Boilers Using Agriculture Waste As Fuel.

Step Grate	250 mg / Nm ³ Particulate Matter
Horse Shoe/ Pulsating	500 mg / Nm ³ (12% of CO ₂) Particulate Matter
Spreader Stroker	500 mg / Nm ³ (12% of CO ₂) Particulate Matter

All Regional Officers and Group In-charges are directed to comply with this from immediate basis. Further, in case of the existing industries which are already under consent mechanism, the emission standards may be revised as per the above in case of any variance to keep uniformity among all such units.


