In compliance of Budget Announcement 2025-26, announcement No.-129[(10 (II)], “प्रदेश में प्रचलित विभिन्न सामयिक मुद्दों के सम्बन्ध में Sustainable एवं Environment Friendly समाधान ढूंढने की दृष्टि से 100 करोड़ रुपये का Rajasthan Green Challenge Fund स्थापित करने की घोषणा”, the State Board is to establish a Rajasthan Green Challenge Fund of 100 crore rupees.
