

## Office Order

The State Board imposes fee in accordance with the provisions of the Water (Prevention & Control of Pollution) Rules & the Air (Prevention & Control of Pollution) Rules based on the gross capital investment of the industry. It has been observed that in cases where an operational project is purchased by a new entity, the new occupier while applying for Consent to Establish and/or Consent to Operate submits the purchase value as the cost of the project for calculation of the applicable fee instead of the previous gross capital investment in the project.

The matter was deliberated upon and it has been decided that consent fee shall be calculated on previous gross capital investment of the project in the land, building, plant & machinery, and miscellaneous assets and **NOT** on the purchase value/ net value/market value. All concerned are directed to ensure compliance of the same with immediate effect.

This bears approval of the competent authority.


