Office Order

In continuation to Board's order no. F.14(5-Adm)RPCB/Plg/347-385 dated 09.07.2021, the following powers with respect to Municipal Sewage Treatment Plants (STPs) having capacity up to 10 MLD are hereby delegated to Regional Officers with immediate effect, to ensure effective implementation of the provisions of Water Act, 1974 and Air Act, 1981:-

- Powers to issue show cause notices for intended refusal/revocation, intended directions and intended legal action under Water/Air Acts.
- Power of grant/refusal of subsequent consent to establish and consent to operate applications after first refusal/revocation (either documentary or based on field observations). In case of more than one consecutive refusal of consent to establish and /or consent to operate application the delegation of power will come to Head Office.

Note:

- Regional Officers should endorse a copy of every show cause notice (as mentioned at point no. A) to the Group In-charge (Liquid Waste).
- In the cases, wherein the coercive action of revocation/prosecution is to be taken by the State Board, the complete case shall be forwarded by the Regional Officers to Head Office with clear recommendation on the proposed action.
