<u>Order</u>

As per the State Board Order no. F.12 (5-Adm) RPCB/ Gen/ 1693-1702 dated 28.08.2023, regarding checklist of documents required to be submitted while applying for Consent to Establish/ Operate/ Authorization/ Registration under Bio-Medical Waste Management Rules, 2016 point no. 7 "Certificate/ Building Plan approved by the competent authority or map certified by a Registered Architect, in case of Health Care Facilities/ Building, Construction, Group Housing/ Hotels" is also a mandatory document along with consent application for all Health Care Facilities.

The matter has been reviewed and it has now been decided that in partial modification to the aforesaid Order dated 28.08.2023, in case of Health Care Facilities with capacity less than 50 beds, in the absence of Certificate/ Building Plan approved by the competent authority or map certified by a Registered Architect, State Board shall also consider self declaration certificate for Building Plan for processing of Consent applications.

This order shall come into force with immediate effect.
