**G.S.R. 15** :- In exercise of the powers conferred by section 64 of the Water (Prevention and Control of Pollution) Act, 1974 (Central Act No. 6 of 1974), the State Government, after consultation with the Rajasthan State Pollution Control Board, hereby makes the following rules further to amend the Rajasthan Water (Prevention and Control of Pollution) Rules, 1975, namely:-

**1. Short title and commencement.**- (1) These rules may be called the Rajasthan Water (Prevention and Control of Pollution) (Amendment) Rules, 2014.

(2) They shall come into force on the date of their publication in the Official Gazette.

**2. Amendment of the Schedule IV.**- In Schedule IV appended to the Rajasthan Water (Prevention and Control of Pollution) Rules, 1975:-

(i) in Appendix A occurring after note 5 of the Notes in respect of the Part I, II and III, the existing serial number 59 and entries thereto shall be substituted by the following, namely:-

“59. Power generation plants excluding the following:-

- (a) Wind and Solar power plants of all capacities.
- (b) Mini Hydel power plants of less than 25 MW capacities.
- (c) DG set of capacity of < 5 MVA capacity.”

- (ii) in Appendix C occurring after note 5 of the Notes in respect of the Part I, II and III, the existing serial number 78 and entries thereto shall be substituted by the following, namely:-

“78. Wind and Solar renewable power projects of all capacities, mini hydel power plants of less than 25 MW capacities.”

**G.S.R. 16** .- In exercise of the powers conferred by section 54 of the Air (Prevention and Control of Pollution) Act, 1981(Central Act No. 14 of 1981), the State Government, after consultation with the Rajasthan State Pollution Control Board, hereby makes the following rules further to amend the Rajasthan Air (Prevention and Control of Pollution) Rules, 1983, namely:-

- 1. Short title and commencement.-** (1) These rules may be called the Rajasthan Air (Prevention and Control of Pollution) (Amendment) Rules, 2014.  
(2) They shall come into force on the date of their publication in the Official Gazette.

**2. Amendment of the Schedule.-** In Schedule appended to the Rajasthan Air (Prevention and Control of Pollution) Rules, 1983.-

- (i) in Appendix A occurring after note 5 of the Notes in respect of the Part I, II and III, the existing serial number 59 and entries thereto shall be substituted by the following, namely:-  
“59. Power generation plants excluding the following,-  
(a) Wind and Solar power plants of all capacities.  
(b) Mini Hydel power plants of less than 25 MW capacities.  
(c) DG set of capacity of < 5 MVA capacity.”
- (ii) in Appendix C occurring after note 5 of the Notes in respect of the Part I, II and III, the existing serial number 78 and entries thereto shall be substituted

by the following, namely:-

- “78. Wind and Solar renewable power projects of all capacities, mini hydel power plants of less than 25 MW capacities.”
