### General Terms and conditions of Bid For Special Ambient Air Quality Monitoring on the occasion of Deepawali festival -2025

- 1. Air quality monitoring shall be carried out for consecutive 15 days commencing  $13^{th}$  October,2025 to  $27^{th}$  October,2025(6:00AM of 28/10/2025) for  $PM_{10}$ ,  $PM_{2.5}$ ,  $SO_2$ ,  $NO_2$  and metals Pb, Ni and As in  $PM_{10}$ ) selected metals/elements (Al,Ba, Fe, in  $PM_{2.5}$ ) to assess the impact of firecracker bursting during Deepawali festival.
- 2. For analysis of regulatory parameters like  $PM_{10}$ ,  $PM_{2.5}$ ,  $SO_2$ ,  $NO_2$  and metals (Pb, Ni and As in  $PM_{10}$ ) CPCB guidelines volume-I may be adopted. For metal/elements analysis in  $PM_{2.5}$  (Al,Ba & Fe in  $PM_{2.5}$ ) (PTFE filter ), EDXRF is the best option however other suitable method (ICP-MS/ICP-AES) may also be adopted. Bidders have to enclosed evidence of facilities available with them for said analysis.
- 3. Bidder must be enclosed a recognition certificate of MOEF& CC.
- 4. Bids must be enclosed in a properly sealed envelope.
- 5. The bidder shall sign the Bid form at each page and at the end in token of acceptance of all the terms and conditions of the Bid
