Sir,

This has reference to your application No Nil dated 10-08-09 seeking environmental clearances for the above project under EIA Notification 2006. The proposal has been appraised as per prescribed procedure in the light of provisions under the EIA Notification 2006 on the basis of the mandatory documents enclosed with the application viz. the questionnaire, EIA, EMP and additional clarifications furnished in response to the observation of the State Level Expert Committee Rajasthan, in its meetings held on 27/28.08.09 & 29.10.09.

2. **Brief details of the Project:**

Environmental Clearance for 10 MW Biomass based Power Plant was accorded by the Authority vide its letter F1 (4)/SEIAA/SEAC-Raj/Sectt/Project / **Cat 1(d)B1(83)/ 08-09** dated 5.5.09 subject to strict compliance of the conditions mentioned in the letter. PP now has applied for expansion from 10 MW to 12 MW.

3. The SEAC Rajasthan after due considerations of the relevant documents submitted by the project proponent and additional clarifications/documents furnished to it have recommended for Environmental Clearance with certain stipulations. The SEIAA Rajasthan after considering the proposal and recommendations of the SEAC Rajasthan hereby accord Environmental Clearance to the project as per the provisions of Environmental Impact Assessment Notification 2006 and its subsequent amendments, subject to strict compliance of the terms and conditions as follows:

1. **The PP shall ensure taking necessary steps on urgent basis to improve the living conditions of the construction labour at site.**
2. **The PP shall ensure that, the EC letter as well as the status of compliance of EC conditions and the monitoring data are placed on company's website and displayed at the project site.**
3. All other terms and conditions imposed by the SEIAA vide its earlier EC dated 05.05.2009 for the proposed electricity production of 10.00 MW capacity {in favour of previous Proponent- M/s Sathyam Power Pvt. Ltd., Rangpur district Kota and later transferred in favour of M/s Prakrithi Power Pvt. Ltd., 7 Nagin Mahal 82, V. N. Road, Church Gate Mumbai (registered with RREC Ltd. Jaipur vide their letter no. RREC/ /39/2004 / Biomass/PPL/D-1226 to 28 dated 22.05.2009)} shall remain unchanged.
